## Requirements Traceability in Support of CMMI certification

The document outlines how CQC Solutions TRC Module provides companies who are attempting to achieve certification based on the criteria for the Capability Maturity Model Index (CMMI) and Requirements Maturity Model (RMM), where there are significant challenges from and both an organisational and process perspective.

The CA Clarity PPM tool provides a Client with significant benefits for those embarking on the certification to CMMI, through the standard tool using workflows and notifications to ensure compliance and governance of a Client's processes and evidenced through the Clarity PPM auditing function.

One of the key areas that has been addressed by CQC Solutions is its TRC Module, offering support to other key elements of CMMI RMM, that being Requirements Traceability.

As can be seen from the chart shown in Fig. 1 below an organisation **must** manage their Requirements to achieve certification for the CMMI level 3&4 and they **should** also manage their requirements for levels 2 & 3, although at these levels it is not a mandatory requirement.
